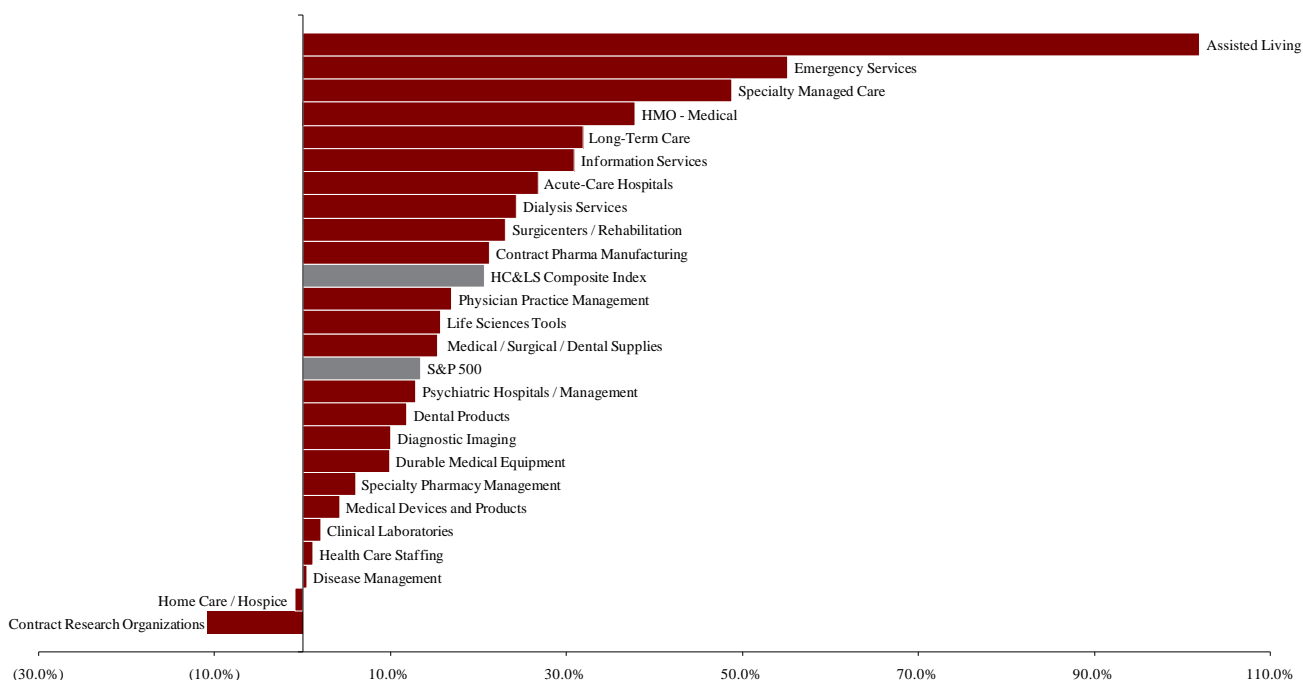


- Scott E. Harrington, a healthcare management professor at the Wharton School, published a policy-oriented paper in response to new federal comparative effectiveness research (“CER”) initiatives. He makes the argument that CER will play an increasingly important role in the delivery of effective healthcare solutions, and that private sector investment in CER should be encouraged by the government through enactment of tax credits and investment in data infrastructure and availability. - April 7<sup>th</sup> marks World Health Day, and this year’s theme is antimicrobial resistance. Appropriately, *The Economist* offers an interesting [article](#) about the increasing prevalence, and associated costs, of resistant strains of bacteria. In fact, the Alliance for Prudent Use of Antibiotics estimates that resistance to antibiotics may cost America between \$17 billion and \$26 billion per year. The article points out that reining in overuse of antibiotics is the key to eliminating these costs, but must be implemented through a coordinated effort by governments, companies, and healthcare providers.
- It’s been one year since passage of the Patient Protection and Affordable Care Act, and Andrew Cohen, of *The Atlantic*, writes that we appear to be about halfway to reaching a legal resolution. Based on the Supreme Court’s historical handling of similar litigation, such as the National Industrial Recovery Act or the Social Security Act, he estimates that it will be Spring of 2012 when the Justices finally begin to hear arguments. - *The Huffington Post* [summarized](#) a study done by the journal *Health Affairs* relating to the incidence of hospital errors in admissions. The study revealed that errors may occur in one third of hospital admissions, and may be historically underreported. These data underscore the fact that adverse events continue to be a major problem in the delivery of healthcare in the U.S., and the need for more integrated and timely data flow is greater than ever.
- In international news, much has been written on increases in healthcare spending in India and China. *The Wall Street Journal*’s [Venture Capital Dispatch](#) points out that as the Chinese middle class continues to grow and change its eating habits and lifestyle, the prevalence of certain diseases, such as heart disease and diabetes, will increase and need to be addressed. Additionally, in March General Electric [announced](#) that it expects its healthcare business revenue from India to grow 25% in 2011. GE Healthcare will invest significant resources in the country over the next few years.

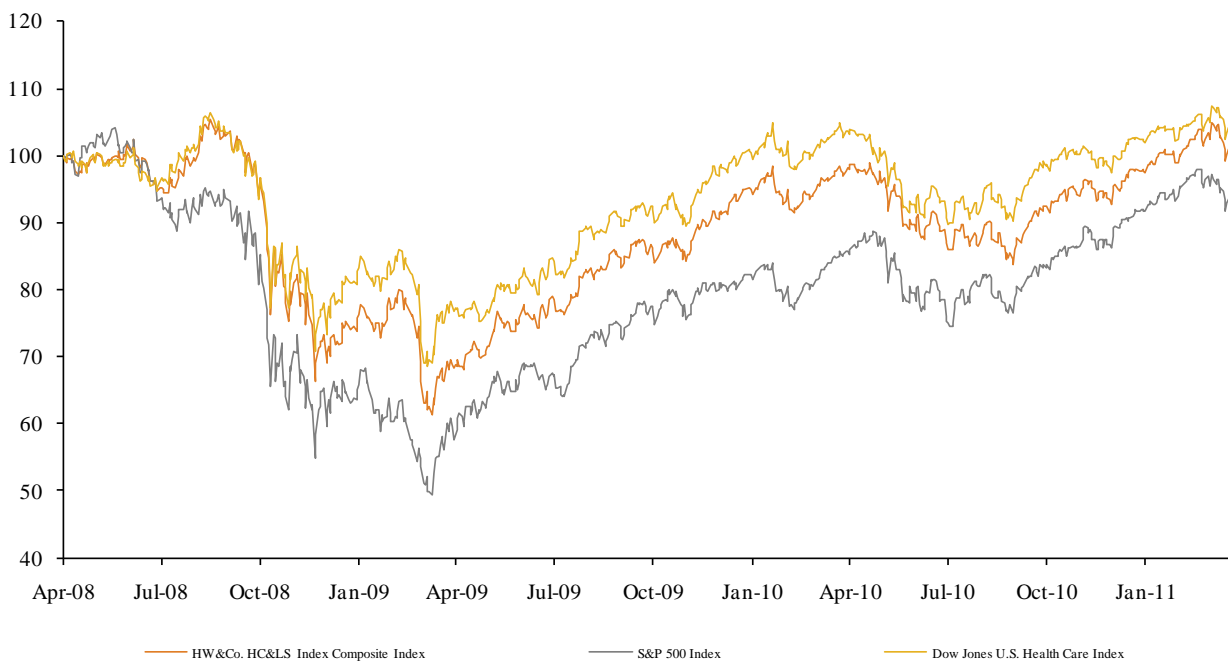
